



# Phase 1 South Toll Rate Range Setting Process PUBLIC HEARINGS



American Legion Bridge I-270 to I-370



The Maryland Transportation Authority (MDTA) is accepting public comments as part of the toll rate range setting process for Phase 1 South: American Legion Bridge I-270 to I-370. Both in-person and call-in public hearings are being held to comment for the official record through verbal public or one-on-one testimony or through written comment.

The in-person testimony public hearing will be held July 12 at the Hilton Washington DC/Rockville Hotel & Executive Meeting Center in Rockville, with two sessions from 2 to 4 PM and from 6 to 8 PM, allowing an opportunity to provide verbal public and one-on-one testimony (advanced registration encouraged). All MDTA staff and participants at the in-person hearing will be required to follow CDC guidance with regards to COVID-19.

The July 14 call-in testimony public hearing will have two sessions from 2 to 4 PM and from 6 to 8 PM, allowing an opportunity for verbal public testimony via telephone (advanced registration - via website or phone as noted in dark blue box above right - is required to be admitted to the phone queue). To provide one-on-one testimony, call 855-701-1977 and leave a single voicemail message limited to three minutes.
